Context

The Institute of the Sisters of Mercy of Australia and Papua New Guinea (“ISMAPNG”) is a Religious Institute of Catholic women who endeavor to advance the reign of God by engaging in the spiritual and corporal works of mercy. Key Accountabilities and Responsibilities

Coordination of Activities

- Raising awareness of YMLV among relevant groups such as Mercy schools, local universities and parishes
- Recruitment and orientation of young adults who desire to be part of YMLV
- Coordination of YMLV activities, including:
 - Providing support to young people as they identify and engage in volunteer activities with third parties
 - Providing opportunities for young people to socialize and engage in ongoing leadership development and formation
- Coordination of YMLV communications, including promotion of YMLV events, through:
 - Social media
 - Email
 - ISMAPNG website
 - Development and distribution of hard and soft copy materials such as posters and flyers
- Where appropriate, support links between the activities of YMLV, other areas of work of the Mission Integration Unit (particularly the emerging ISMAPNG Faith, Life and Ministry Education (FLAME) framework) and the Mercy Action and Spirituality Hub
- Regular evaluation of the direction and activities of YMLV
- Contribution to the development of a broader YML network where capacity allows.

Key Challenges in Achieving Goals

Qualifications, Experience & Competencies

- A commitment to uphold and support gospel values and Mercy ethos
- Experience working with young people (aged 18-30) energised by gospel justice
- Demonstrated ability to coordinate and animate young people in areas such as justice education, volunteering in the community, outreach, solidarity immersions and pilgrimages
- Ability to think strategically and convey ideas
- Ability to work collaboratively and independently
- Vision and enthusiasm for young adult ministry
- Competent administration skills relative to the role requirements, including management of program budget
